While we would like to be able to accommodate everyone, the impact is that the team investigating the incident and the office team are unable to continue with their duties, including but not limited to resolving the incident in question. As such, the school has to operate a system of appointments only. If you would like a meeting to discuss an issue, please contact the office team to arrange.

### Weekly Enrichment

As previously shared by the Education Secretary in October, mobile phone and social media usage in UK schools is having a direct impact on bullying, disruptive behaviour and attention within lessons. There are also clear links between screen time, social media and poor mental health.

Within the statutory guidance 'Keeping Children Safe in Education' it has stated 'that children's unlimited and unrestricted access to the internet via mobile phones means that some children, whilst at school or college, sexually harass their peers via their mobile and smart technology, share indecent images non-consensually (often via large chat groups) and view and share pornography and other harmful content.' Ofsted's rapid review of sexual abuse in schools and colleges, published in June 2021, has additionally highlighted mobile use in the sexual harassment of school girls, with the majority of the more than 900 children and young people surveyed, experiencing some kind of unsolicited images or sexist comments online or via mobile phone.

We have a clear expectation on mobile phones within school, they should not be seen or heard and we are working hard to ensure we are creating a positive culture around online safety within SET Ixworth. This includes work in PSHE and tutor time, alongside working with external agencies, to ensure students know how to be safe online, along with reporting harmful or negative content online.

To keep your children safe, there are a range of parental apps including, but not limited to; <u>Qustodio</u> **Google Family Link** <u>Kaspersky</u>

Alongside this, I would highly recommend you read further advice about online safety from the NSPCC Keeping Children Safe which covers key topics such as the links between online safety and mental health, apps and social media, online games, and fake news and misinformation.

We wish to work with parent/carers to ensure that all young people are remaining safe online, so if you have any concerns or would like to discuss this further, please don't hesitate to get in contact with a member of the Safeguarding Team.
